




# Community Research Advocates (CRAs): Research Ready Program

- An outreach program offered by CRAs to community members to help them become "Research Ready".
- CRAs are community representatives with a personal connection to communities and/or specific diseases
- CRAs share the Research Ready story which explains what research is, how research participants are protected, and the critical value of having people of all backgrounds participate.
- CRAs can work with traditionally trained researchers to help them tailor their community messaging, expand populations.
- Awarded funding from UCCC COE/Urban Health to create a cancer-focused Research Ready CRA program

- Developmental psychologist
- Research focus: Exposures and experiences that may alter the trajectory of development across childhood
- MPI of HOME Study Longitudinal pregnancy/birth cohort examining exposure to ~100 environmental toxicants on child health and neurobehavior from infancy to young adulthood
- MPI of newly funded C4 study combining HOME with CCAAPS
- Collaborate on studies of maternal stress and opiate exposure during gestation
- Consult regarding assessment of neurobehavioral outcomes from infancy through adulthood for multisite and single site studies



# Lincoln Heights

- 1st majority African-American, selfgoverning municipality north of the Mason-Dixon line.
- Borders a Cincinnati Police Department Firearms Training Center – 80 years
- Concern: Lead exposure to children along "fence line" of firing range
- Partners: Heights Movement, St. Simon of Cyrene Episcopal Church, Princeton City School District, University of Cincinnati
- Episcopal Church's Creation Care and Environmental Justice Grant due today, April 16<sup>th</sup>.

#### Green Loop

#### Relationship between CEC & Community

- Build trust
- Gain awareness (needs, questions, EH concerns, skills, knowledge, etc)
- Share information (re: Center and re: community)
  - Establish foundation/groundwork for collaborative efforts
- Build capacity for community-led/cit.sci. projects

#### Yellow Loop

#### **Interaction between CEC & Center (members)**


- Increase awareness of community questions/context
- Identify Center "assets" to address/meet community questions
  - Could include making connections between community groups and Center member(s)
- Identify gaps/opportunities within the Center (may include community participation in these discussions)

#### **Light Blue Loop**

#### Interaction between Center (members) & Community

- Center member(s) responding to community questions/concerns, which could include:
  - CEnR through pilot, career development, IHSFC, other
- CEC role could include Technical Assistance or Capacity building for Center member & residents
  - Enable/promote proper CEnR
  - Ensure sustainability
  - Promote communication/reporting back of results



- US EPA




### **ENVIRONMENTAL INJUSTICE IS COMMON**

- Toxicant exposures tend to occur in neighborhoods with lower SES & high minority populations
  - Lead
  - Air pollution
  - Toxic sites

- Example diseases
  - Childhood lead poisoning
  - Coronary heart disease
  - Asthma

# Background

- Late 90s: direct action work River Valley Schools, WTI Toxic Waste Incinerator, and Steel Plant
- Housing, lead, gentrification in over-the-rhine
- Treatment Technology Evaluation Branch U.S. EPA
- Creating Healthy Community Coalition Cincinnati Health Department
- Rhetoric and Professional Writing
  - Environmental Writing (4093), Scientific Writing in the Behavioral Sciences (3062), Intro to Environmental Writing (2193), Writing for Justice (2073)

# Ongoing EJ Projects

- Equity in Access to Greenspace
- Sustainable Urban Agriculture and Community Building
- Justice and Relief from Exposure to PFAS in Clean Cape Fear River Basin
- Community Perceptions of Pollution Study in a Fenceline Community
- Environmental Justice and Advocacy Interdisciplinary Curriculum Development

# Equity in Access to Greenspace

- Partner with Rockdale Academy and Preserve Burnet Woods
- Provide opportunity for underserved youth to experience and learn in greenspace
- Listen to and follow the lead of CRC and STEM instructor at Rockdale
- Collective Impact UC > Rockdale > PBW
- Nearly 100 engaged youth
- Approx. 40 engaged undergrads





# Sustainable Urban Ag and Community Building

- Partner with Gamble Montessori and Enright Urban Ecovillage
- Provide capacity building for Enright and mentorship for youth
- Respond to Gamble Montessori faculty member's request for programming
- Authored capacity-building grant proposal for Enright
- Over 100 hrs. service to Enright
- Field trips/access to produce
- Collective Impact UC > Gamble > Enright



# Justice and Relief from PFAS exposure

- Serve the Clean Cape Fear (CCF) group in North Carolina
- Conducted discovery meeting with CCF leadership to \*listen\*
- Developed and executed a petition to regulate PFAS as a class
- Building long-term partnership to support CCF
- Building on EJAS 2021, a national symposium with nearly 200 attendees



# Fenceline Research

- Partnering with Ohio Sierra Club and The Cincinnati Project
- Canvassing residents of fenceline neighborhoods to assess perceptions of health and property risks from source pollution

 CBPR: working with community members from inception through completion

- Participant compensation
- Two undergraduate RAs

# Interdisciplinary EJ Curriculum at UC

- Awarded Interdisciplinary Faculty Team Development Grant
- Founded the EJ&A Task Force of 20+ Members
- Developing curriculum that will appeal to a wide range of students and prepare them for a wide range of professions in EJ work
- Listening to practitioners, the community, policy makers to develop effective curriculum responsive to the state of the EJ field
- EJAS 2021



# Takeaways from Cases of EJ Work

- Listening: shifting the \*savior\* paradigm to a \*service\* paradigm
- Removing: the town/gown barrier, stigma, and constraints
- Shifting: our perceptions of who is an expert
  - Testimonial justice
  - Hermeneutic justice
- Engaging: with members of the community from concept to completion (CBPR), and creating interdisciplinary spaces/action
- Expanding: our impact by pursuing collective approaches to the work
  - University > Community Stakeholders > NGOs > Undergraduates
