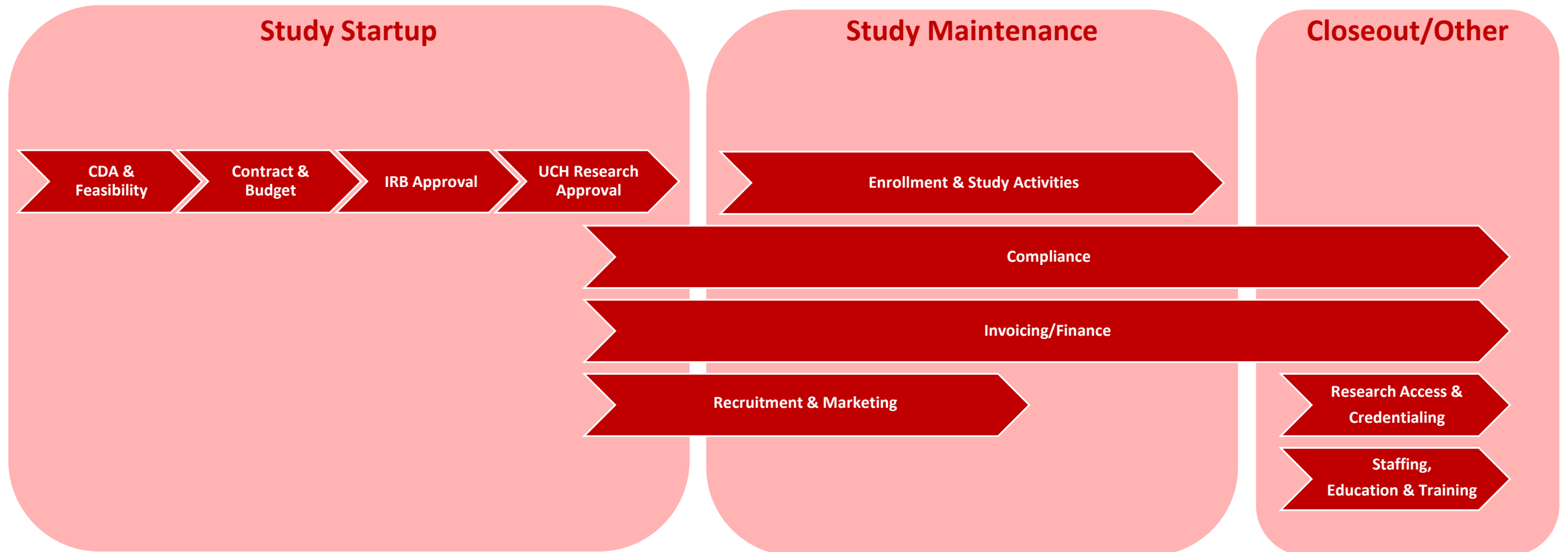

Clinical Research Pathway at UC/UC Health

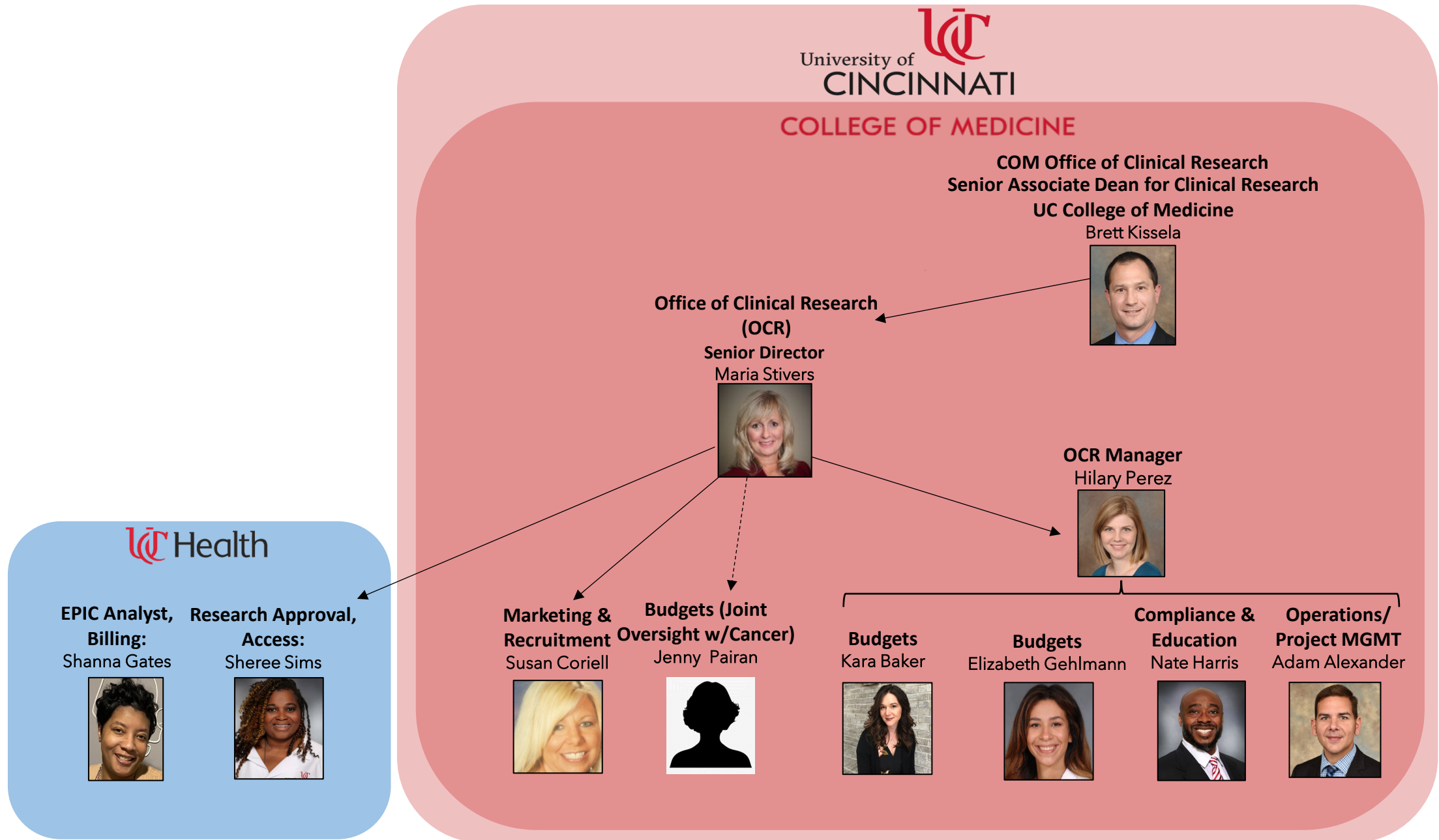
